

Our 2024 Impact: Hard at Work Across the Country

From coast to coast, we successfully challenged pregnancy-related criminal charges, defending the rights of pregnant people, took our message straight to policymakers, and gathered thought leaders for a powerful convening affirming pregnant people's personhood. Here's just a snapshot of our work.

Minnesota

After hearing from us, the Hennepin County district attorney announced that she would stop pursuing pregnancy and substance use cases and dismiss all pending cases

Kentucky

Testified against a fetal personhood bill that would have required child support payments for embryos and fetuses, which didn't pass

California

After several years of vigorously defending our client against a murder charge for experiencing a neonatal loss, the prosecutor dropped the charge

Oklahoma

Organized against a bill that would create a new crime of "fetal assault," which didn't pass

Mississippi

Supported local counsel in defending a woman facing domestic violence charges against her fetus, resulting in a dismissal

New York

Co-hosted "Personhood and Pregnancy" convening with more than 80 advocates, litigators, and scholars at NYU Law to develop new pathways to dismantle fetal personhood and affirm pregnant people's personhood

District of Columbia

- Testified before the U.S. Senate Judiciary Committee about fetal personhood's link to pregnancy criminalization, IVF, abortion, contraception, and maternal mortality
- 60 congressional staffers attended our briefing on our report, *Pregnancy as* a Crime
- Members of Congress cited our research to urge the White House to protect against pregnancy criminalization
- Supported our client, who was subjected to torture while giving birth in jail, in her testimony to the Senate Judiciary Committee's Subcommittee on Human Rights

South Carolina

A grand jury refused to indict a young woman for murder for her miscarriage after we organized against the prosecution

Alabama

Successfully challenged the prosecution of a client for a stillbirth at home



Setting the Record Straight with Trailblazing Research

Released our report, *Pregnancy* as a Crime, documenting a disturbing 210 prosecutions in the year after the *Dobbs* decision, showing that while abortion bans are a threat, prosecutors continue to wield non-abortion laws to criminalize all pregnancy outcomes.



Filing Amicus Briefs Across the Country

Filed 5 amicus briefs from Maryland to New Mexico to the U.S. Supreme Court. Our briefs include arguments challenging state laws that deny emergency abortion care and a prosecutor's use of a woman's consideration of an abortion to justify a murder charge.

Providing Legal Defense and Advocacy

Represented or advocated for nearly 30 people across 16 states facing pregnancy-related charges ranging from murder to child abuse to domestic violence of a fetus.



Training Professionals to Disrupt Pregnancy Criminalization

Trained nearly 5,000 prosecutors, criminal defense attorneys, activists, medical professionals, medical students, law professors, law students, and policymakers across the country about the dangers of pregnancy criminalization and fetal personhood and what actions they can take to defend the rights of pregnant people.
