1 <u>Expert Witnesses and Scientific / Medical Evidence Support</u>

Pregnancy Justice can help with identifying, engaging, and paying for experts. From OB/GYNs, to specialists in substance use disorders during pregnancy (impact of drug use on pregnancy and/or breastfeeding), to medical examiners, toxicologists, psychologists (unperceived pregnancies, etc.), and placental/neonatal pathologists.

2 Policy / Legislative Support

Offer advice or guidance around how proposed laws or changes in laws in your jurisdiction might affect your client, as well as advocacy support for legislative change.

3 Co-Counsel / Direct Legal Support

- Pregnancy Justice can join your representation as co-counsel in civil, criminal or appellate proceedings. Pregnancy Justice will bring its expertise in constitutional/civil rights violations, criminal law, or systemic issues (e.g. a law that criminalizes behaviors during pregnancy or fetal personhood), as well as bad forensic science (non-consensual hospital drug testing, FIGG and the lung float test), to your cases.
- Pregnancy Justice can assist in interventions on behalf of a client who is under investigation, forced to give birth in untenable circumstances, or threatened with prosecution.
- Pregnancy Justice can help develop amicus and post-conviction litigation strategy with practitioners by submitting amicus briefing and finding experts in the field to write amicus briefs, drafting post-conviction relief briefing, and supporting post-conviction relief hearings (e.g. direct and cross outlines, etc.)

4 Strategic Defense Tools

Provide exemplars and drafting support. Pregnancy Justice can open its litigation library and share briefs, motions (to dismiss, Daubert, etc); arguments challenging forensic methods; challenging child welfare interventions based on conduct during pregnancy, prosecutorial overreach challenges.

5 Training and Skill Development

- Provide access to CLEs, workshops, and training sessions specifically about pregnancy criminalization.
- Education for defense teams about relevant medical science, substance use in pregnancy, pregnancy loss etc.

6 Communications / Public Advocacy

- Help support or drive media/narrative to shift public perception or generate strategic media attention where appropriate.
- Provide tracking of similar cases and trends, important precedents, and context around typicality of prosecution approaches.

7 Resource Lists, Materials, Manuals

- Access to publicly available reports and toolkits.
- Assemble research that may be of use in cases.
- Provide and incorporate research and data.
