

# JUSTICE Top Moments of 2025

# **January**

With the ACLU of Vermont and local counsel, we file a lawsuit for a mom whose newborn was taken by child welfare after being secretly investigated while pregnant, challenging the agency's practice of tracking pregnant women it deems "unsuitable" for parenthood.

# **February**

We help secure wins in two cases: the Maryland Supreme Court overturns the murder conviction of a woman who experienced a stillbirth, and an Oklahoma judge dismisses our client's child neglect charge.

#### March

Our client's manslaughter charge for suffering a stillbirth is dropped after we file a motion to dismiss with local counsel in Ohio.

# **April**

Amid public pressure, including our legal analysis featured in dozens of news articles, a Georgia prosecutor drops charges against a woman who was arrested after miscarrying at home.

# May

We co-organize a rally with the New York Informed Consent Coalition in support of a bill requiring pregnant patients' consent to be drug tested. The bill goes further than before, and we will fight for its passage in 2026.

### June

With co-counsel, we announce a settlement in a years-long federal civil rights lawsuit on behalf of Ashley Caswell, allowing her to move forward after experiencing horrific treatment in an Alabama jail while pregnant.

# July


We publish a report on the 2025 legislative season, highlighting 15 bills – the most in a single year – that would allow homicide charges for someone getting an abortion. None of the bills pass.

# **August**

We testify before United Nations member states in Geneva as part of a coalition of organizations documenting the United States' human rights abuses of pregnant people and other marginalized groups.

# September

We publish new data on pregnancy-related prosecutions, documenting 412 cases in the first two years after the Dobbs decision.

#### October

Along with state-based partners, we help bring national attention to South Carolina's "abortion as homicide" bill. The bill failed to make it out of committee in November 2025.

#### November

We launch our first-ever national digital campaign on the real-life risks to pregnant people's rights.

### **December**

Pregnancy Justice staff gathers to celebrate our wins and strategize for 2026.
